HOW IT WORKS

POINT ROLLOVER

Don't have enough points for a trip? Just choose the point rollover feature at redemption time, and we will carry the points toward next year's trip! Points may be rolled over for one year only and do not apply to consecutive years.

NEW TRAVEL REQUIREMENTS IN 2025

Beginning May 7, 2025, the Department of Homeland Security will require a REAL ID compliant driver's license/photo ID card marked with a **STAR** or the word "**ENHANCED**" or another form of federally acceptable identification (such as a valid US passport or Military ID) to board a domestic commercial flight or enter a federal building or military installation that requires ID to be presented upon entry.

If there is not a **STAR** or "**ENHANCED**" on your driver's license/photo ID card, or if it reads "**NOT FOR REAL ID PURPOSES**," it will not be considered a federally acceptable form of identification starting on May 7, 2025. Should you wish to upgrade your driver's license/photo ID card to a REAL ID, please visit the website www.dhs.gov/real-id-public-faqs for more information.

As a reminder, upgrading your driver's license or ID card to a REAL ID is optional but mandatory if you plan to use your ID for domestic flights. If you do not have a REAL ID compliant driver's license, you will require a valid US passport for a domestic flight. To apply for a US passport, please go to travel.state.gov.
